

Introduction to the seminar

Liberalisation and privatisation can be expected to have profoundly altered the structure of public-service sectors in Europe. New rules introduced by European directives and regulations should have created pressure for Member States to converge to a common model of governing markets and undertakings.

A lot of questions arise in this field. Does this common organizational model actually exist? Are markets really more competitive and contestable than before? Is the role of the public authority concretely changed? How?

The seminar aims at addressing these questions, focusing on local services of general economic interests that include heterogeneous sectors, having in common the important role acquired by the public authority and the local nature of the service.
